AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of Anderson Island Fire & Rescue from January 1, 2017 through December 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended December 31, 2019, 2018 and 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Accounts payable – general disbursements, credit cards, travel expenditures, electronic funds transfers
- Payroll – gross wages, overtime, and bonus and incentive payments
- Procurement – purchases, professional services, and joint purchasing agreements
- Open public meetings – documentation of minutes, executive sessions and special meetings
- Tracking and monitoring of theft sensitive assets, such as computers, tools, and equipment

INFORMATION ABOUT THE DISTRICT

Pierce County Fire Protection District No. 27 provides 24-hour volunteer basic life support, fire suppression services and fire education services for Anderson Island. As of 2019 fiscal year-end, the District has four full-time employees and 23 volunteer firefighters.

The District is governed by a three-member Board of Commissioners elected to staggered, six-year terms. The District operates on an annual budget of less than \$1 million.
